### **CSL LEGISLATIVE SESSION STATE TOP PRIORITIES**

**AP-2 Sr. Asy. Member Young-IHSS Provider Auto Insurance.** Bill would prohibit a vehicle covered under an auto liability policy from being classified as a common carrier, etc., solely for the reason that the named insured or applicant is operating or using the vehicle to provide transportation incidental to the provision of the in-home supportive services

**AB 2139 Asy. Member DE LA TORRE. SENATE Bus. & Finance Comm.- 3<sup>rd</sup> READING No chg.**

**AP-4 Sr. Asy. Member Krohn-Expanded Elder Abuse Reporting.** Bill requires long-term health care facilities and local ombudsmen to report suspected elder abuses to Attorney General and district attorney. **AB 2100 Asy. Members Wolk/Berg/ Krekorian- Enrollment-Gov. signature**

**AP -12-Senior Assembly Member Serrin: Senior Shared Housing**

**NOTE: REVISED TO AJR 21-**

**AP-13 Senior Assembly Member Fingold: Acute Care Hospital Infection Screening.** Requires general acute care hospitals to administer weekly screenings of infections and to publicly disclose the number of patients developing infections. **-SB 1058 Senators Alquist/Florez Rereferred to Assembly Appropriations Committee- held for 3<sup>rd</sup> Reading.**

**AP-19 Senior Assembly Member Trotter (2-YEAR BILL). Senior Facility Infrastructure Upgrades. SB-977-Senator Correa.** Bill declares the intent of the legislature to enact legislation that would require the preparation of a statewide study to determine the current and future infrastructure needs. **Rereferred to Asy. Approp. Comm. –Unfinished business to be heard Aug. 18.**

**Sr. Asy. Member Krohn-AB 2543 –Asy. Member Berg.-WORK FORCE EXPANSION ACT.** Would establish the Geriatric and Gerontology Workforce Expansion Act to provide loan repayment assistance to professional medical workers working in a geriatric care setting, as specified. The fee would be raised \$10. or \$50 as specified. **Senate Appropriations Comm. Held for 3<sup>rd</sup> reading.**

**SP- 18 Sr. Asy. Member Messler – Mellow-Granlund Definition of Disability.** Amends Mellow-Granlund Older Californians Act to define disability. **AB 2160 Asy. Member Carter. Senate Appropriations Committee – Enrollment – Gov. Signature.**

**SP -29 –Sr. Senator Kim-Selby--Senior Volunteer Month.** Proclaims the month of May to honor Volunteers. **Assembly Member Huffman. ACR 111** **--Chaptered 34 by State**
