## **CSL Program Book Ad Submission**

This book is color. Electronic copy submission is preferred. The book is prepared in Adobe InDesign using the CMYK color model. Note that in this book the lines separating ads are part of the book design and should not be included in your ad. Your ad may abut those lines; otherwise you need to provide margins within the space.

Ad placement is completely the responsibility of the producer, and is based on factors such as ad design and mix of sources with an objective of obtaining diversity for each page.

We offer options for ad preparation:

1. CSL members who wish Business Card size ads may send their CSL business card with the order form, and we will do the rest. (The logo will be a color logo but the charge is still \$35.00)
2. Complete ads may be submitted by email in Illustrator or InDesign format.
3. Complete ads may be submitted by email as graphic images acceptable to Adobe Pagemaker, Adobe Photoshop, Adobe InDesign, or Adobe Illustrator: tif, jpg, bmp, gif, psd, etc. Resolution must be **at least 300 dpi**.
4. Word or Publisher documents by email are acceptable, but will be reset.
5. You may negotiate ad copy and images with us and we will create the ad: see the contact information below.
6. You may submit printed (hardcopy) images which we will scan and place. These should not contain halftone elements. Please do not submit printed electronic images (email the electronic image itself).
7. You may instruct us to use last year's ad.
